MIGLIAZZO PARK: More Playground Improvement Ideas

Hello Friends and Neighbors. My name is Becca Allen, and I'm delighted to join the Verona Hills HOA Board this year. I look forward to meeting more of you at our beautiful neighborhood park. I have been charged as a neighborhood representative for the parks department, to relay the Verona Hills neighborhood's wants and needs to the Parks Department and combine our efforts to make Migliazzo Park the best it can be for us to enjoy. As such, I had a meeting with the Parks Department earlier this year and would like to share with you how that went.

First, I've had a few people tell me they would like to see a public restroom added to the park. Some parents unfortunately have to cut their park visits short in order to hurry their little ones to the nearest restroom. When I approached this topic with the Parks Department, I was told how the city is finding it a challenge to keep the local homeless population from seeking shelter within the public bathrooms and using the bathrooms for some nefarious purposes. Therefore, as a neighborhood that would like to keep such activity out of our local park, it is unlikely we'll get a public restroom added at this time.

Second, I mentioned to the Parks Department that Migliazzo Park is an excellent place for picnics and kids' birthday parties; however, a shelter would really be nice on days the rain wants to spoil the best-laid plans. A shelter would be a simple and inexpensive addition to the park, and I was told there's a very good chance of getting that project approved. Therefore, I will be submitting a request to the Public Improvement Advisory Committee (PIAC) to see if we can get that added to Migliazzo. I will be sure to keep you updated on that process.

Thirdly, I am sure many of you and our local children have enjoyed the new playground equipment that was added just over a year ago. However, in the summer months, the playground is directly in the sunlight for the majority of the day, making the equipment too hot to touch and uncomfortable for children to use for very long. I inquired about having some sunshade or canopies added over the equipment, protecting the equipment from the harsh rays, and keeping children a few degrees cooler while they play. This suggestion was also met with positive feedback.



Again, I was encouraged to complete a PIAC request. This likely won't be something we can have completed for this summer, but fingers crossed we can have it added for Summer 2025. Again, I will keep you updated on our progress.

In the meantime, feel free to reach out to me with any questions you may have for our Parks Department regarding Migliazzo Park. I am sure that together, we can get a lot accomplished for our beautiful Verona Hills community!

COMPLIANCE CORNER: Who's Responsible for the Area Between Your Sidewalk and Your Street?

With the storm damage that has occurred this spring and summer, we've received a few inquiries about who is responsible for the area between a home's sidewalk and the street. The short answer is the homeowner. The full answer is a bit more complicated.

The area between the sidewalk and the street is part of a home's "curtilage", which is just a fancy way of describing the space surrounding a home. Interestingly, there's a long history of lawsuits about this type of space, largely arising out of whether the police have the right to search trash bags and receptacles placed in this area outside of a home without a warrant.



In any event, homeowners are ultimately responsible for maintaining the green space between their sidewalk and the street. That includes keeping the grass cut and cleaning up yard debris and damaged limbs following a storm.

But there's one caveat – in many parts of the City, it was actually the City that planted trees in that space between the sidewalk and the street in the first place. So who is responsible for those? Ultimately it's still the homeowner, but if a tree located between the sidewalk and the curb suffers extensive storm damage, it would be wise to call the City's "311" line to request that the City contend with the damaged tree. Sometimes the City says yes, other times the City says no, but the answer is always no if you don't ask.

Who's Interested in Becoming the New Director of Compliance?

To wrap up this column, I have stayed on as the Director of Compliance for a couple of years past my initial term. Now it's time for me to step down to attend to some of the other boards for which I volunteer. As a result, we're looking for a new Director of Compliance to take my place.

This position has often been filled by a lawyer in the neighborhood, but that's not actually required at all. Instead, the Director of Compliance is primarily responsible for answering basic questions from homeowners who are looking to erect a fence, add a pool, add on to their home, build a deck, and the like. It's a pretty easy gig, as the answers are always the same, and I'll be available to assist whoever takes on this role until they are comfortable in the position. TREASURER'S REPORT: Annual Dues and Liens Collected



Our fiscal year runs from June 1 through May 31, with annual assessment of \$150 due by June 30 each year. Our assessments have not been raised for many years, and they are meant to be affordable for all our residents. Please make sure to pay your assessments on time. They allow us to enjoy many of the core services you have come to expect and are highlighted in this newsletter, as well as continue to evaluate other services and events for the benefit of our neighborhood.

Did you know you can pay your dues online? Go to our website, www.veronahills.org, and our online payment portal is front and center! You will be able to make a one-time payment or set it up on auto debit going forward. You will only need your account number which can be found on your dues statement, or by calling our management company Homes Associations of Kansas City at 913-385-2440.

We have a collection policy in place that includes filing liens on properties once they become due for a third year on their assessments. Once a lien is filed, not only are individuals being invoiced for past due assessments, but also interest is added at 8% on the balance, and legal expenses incurred by the Association are included. Once an assessment is over four years past due, we are obligated by our Homes Association Declaration to file suit to collect the delinquent assessments. This action increases expenses, including legal, filing fees and court costs, which are added to the delinquent assessment amount. The cost to file a lien is approximately \$100, and the average expense if an account goes to trial is over \$1,000.



In addition, a filed lien or judgment may have negative consequences on your credit rating. Overall, your Board of Directors would rather spend our volunteer time (and your hard-earned money!) providing services and improving the neighborhood, rather than exhaust the time and money collecting delinquent accounts. Further, it is not fair to the homeowners who pay when the assessments are due.

Our cash flow statement for the previous fiscal year is on our website. As a board we can confidently say our neighborhood remains in strong financial standing, with ample reserves to position us to address any unforeseen problems, continue to keep our streets safe from inclement weather, and further invest in our neighborhood. SECURITY UPDATE: Statistics & Safety of Our Neighborhood

Since our last newsletter at the end of last year, REPORTED crimes as of 6/19/24 have stayed level. We've had 1 assault, 1 domestic violence, 3 property damage, 1 burglary, 3 stolen autos, and 1 theft from vehicle. Based on feedback from neighbors, it sounds like more crime has been committed, but we only know about the crimes reported.

We continue to stress the importance of reporting crimes no matter how small. The data is what drives additional patrols and attention from the city. If you just want to report a nuisance individual and don't need immediate attention, it's best to call the South Patrol non-emergency number at 816-234-5550, option 4.

The best way to prevent criminal activity is to reduce opportunities by keeping garage doors closed, doggie doors protected, your home well-lit, and your vehicles and home securely locked. By FAR, most reported crimes are ones of opportunity and folks letting their guard down with an open garage or unlocked car.

If you need to request additional patrols in a specific area, you can request that online at www.kcpd.org. Crime stats can be found via kcpd.org or cityprotect.com. It's a great resource to monitor how we are doing relative to surrounding communities.

If you have surveillance cameras on your home, please register with WatchKC so you can be a part of the solution to crime in our city. For more information or to register, visit www.kcpd.org/get-involved/watchkc.

We are up to 7 neighborhood cameras currently. If you experience any type of crime, please feel free to reach out and we will look through the footage and pass along to South Patrol for their review. We are still looking for more volunteers for camera installation on their homes! This is a ZERO cost opportunity for you. If you have a home near a high traffic location that would be considered an entry or exit point for Verona Hills, your home may be a great location to install a FREE camera. Please email dave.bman@icloud.com if you're interested in participating.

In the last security update, we had recently completed a traffic survey to see what can be done to improve safety for kids crossing Minor Drive at Pennsylvania (heading to Migliazzo Park). We have started the process to hopefully fund this project through local Public Improvement Advisory Committee funds (PIAC funds). Overall, we believe that Verona Hills is a safe place to live with the help of caring and alert neighbors, Titan Security, and KCPD.
